

GUIDELINES AND SELECTION CRITERIA Arbour Scholarship - Master's (Professional or Research)

Eligibility

The master's Arbour scholarship competition is open to full-time students registered in selected master's programs at one of the following universities that partner with the Arbour Foundation: Bishop's University, Concordia University, École de technologie supérieure, HEC Montréal, Institut national de la recherche scientifique, McGill University, Polytechnique Montréal, Université de Montréal, Université de Sherbrooke, Université du Québec à Montréal, and Université Laval. In accordance with its mission, the Foundation only recognizes programs from one of the following domains — engineering, computer science, administration. It is the applicant's responsibility to check with his or her university to see if his or her program of study is eligible.

To be eligible, **students must**:

- have completed at least 2 full-time semesters in a Québec university in the past 12 months*. These 2 full-time semesters do not necessarily have to be in the same field of study as the master's degree currently sought out;
- be enrolled **full-time** in a master's program (during the fall and winter semesters following the scholarship application);
- have a university average grade of at least 75% (cumulative average of the last diploma obtained or of the last session(s) of the current diploma);

Sudents are eligible to receive a scholarship if they have at least two full semesters remaining in their program at the time of the first scholarship instalment (one fall and one winter semester).

*NOTE: If the university has granted a study leave (for maternity or illness), the student must contact the university to determine if he or she is still eligible for the scholarship.



Selection Criteria

^{*} Financial need is a key criterion for the Arbour Foundation. The Foundation recognizes that each case is unique and is committed to evaluating each bursary application taking into account the particular situation of each student. However, it is important to note that any student receiving an external source of funding (other bursary or family assistance, for example) in excess of \$30,000 for the year of study for which he or she is applying for an Arbour Scholarship will not be awarded a scholarship.

A 30% quota is imposed on each university as to the number of international student applications that may be forwarded to the Foundation's selection committee, i.e., approximately one-third of all applications submitted (all types of scholarships combined).

Instructions to submit an application

A complete application file must include:

- The completed application form for the Arbour scholarship including consent for the privacy policy (downloaded from the Foundation's website and completed in a web browser or with Acrobat Reader – please respect the maximum number of words indicated);
- The following supporting documents:
 - V **Proof** of Canadian citizenship, permanent residency or study permit
 - V All **official** university transcripts **in** English, French or Spanish
 - V Letter of support from an **academic sponsor** (details in the Letters of support section)
 - Letter of support from a non-academic sponsor, with no family ties to the candidate (details in the Letters of support section)
 - √ CV
 - √ List of publications (if applicable)

Applications must be submitted directly to the university where the candidate is registered. As each university sets its own procedures and deadlines, it is the student's responsibility to get the proper information. Applications sent directly to the Foundation by candidates will not be accepted nor considered. This applies to the application form, transcripts and letters of support as well as any other document sent separately to the Foundation.

Finalists are first selected by the universities from all applications received. The universities then forward the best applications to the Foundation.

The Foundation's selection committees then select the candidates to be interviewed from among the applications proposed by the partner universities. Any finalist not invited will be notified by the Foundation.

Selected finalists will be invited to an in-person interview (or virtual interview in the event of 'force majeure') that will take place between mid-August and mid-September.

Once all the interviews have been completed, the Foundation will select the finalists who will receive an Arbour scholarship. **Not all finalists will receive a scholarship.** By mid-September, all finalists will be informed of the decision of the selection committee as to whether or not they are awarded a scholarship.

Instructions for the letters of support

Two letters of support must be included in the application file:

- The first letter of support must be from an academic sponsor who will highlight the candidate's academic performance as a mandatory theme and, as an optional theme, his or her social involvement in an academic environment.
- The second letter of support must be from a non-academic sponsor who will discuss the candidate's merits outside the academic community.

All letters of support must be on the official letterhead of the organization and signed by the sponsor with their name, title and contact information indicated.

Value of scholarship and disbursement

The value of the master's Arbour scholarship is \$20,000. Scholarships are disbursed by the university in two equal instalments – one in the fall semester and the second in the winter



semester – upon presentation of a full-time registration proof. Master's Arbour scholarships are renewable once. See guidelines for renewals for more details.

Important note for potential scholarship recipients who speak little or no French

The mission of the Arbour Foundation is first and foremost to contribute to Québec's economic growth through education. For this reason, it is important for international and Canadian students who speak little or no French to acquire this competence to fully participate in Québec's society and economy. The Arbour Foundation is currently working to facilitate their integration with a mentoring program, networking events and various other activities geared towards the same goal.

Since French is a key element in Quebec's cultural integration. the Arbour Foundation wishes to encourage all the students with little or no French skills to take lessons on a regular basis. To this end, the Foundation is partnering with the *Fondation pour la langue française* to offer French training at various levels of fluency to its scholars.

As of September 2021, the following protocol applies to new and returning scholars:

- The Arbour selection committee evaluates the French skills of each candidate during the selection interview.
- Candidates getting a scholarship whose level of French is deemed inadequate are
 personally notified by the Arbour Foundation. They receive the first instalment of their
 scholarship in the fall semester (October), but the second instalment (February) is
 conditional to attending on-line or in-person French lessons provided by the Fondation
 pour la langue française AND receiving a positive evaluation from their instructors.
- The same conditions apply for renewal applications for a second term.
- Students are encouraged to participate in weekly lessons (1 to 2 hours maximum each) during both semesters (fall and winter).
- There is **no charge for these lessons**, as they are fully subsidized by the *Fondation pour la langue française*.
- Training is offered at various levels of fluency, either in groups or individually. Lessons can
 take place at various times during the week, especially over lunch, to best accommodate
 the students' busy schedules. The Fondation pour la langue française assigns each student
 to the most appropriate format.
- There is no written exam, but simply an ongoing evaluation by the instructors from the Fondation pour la langue française. This evaluation is sent to the Arbour Foundation at the end of December of the current year and again at the end of June of the following year. If the December evaluation is positive, the second instalment (February) of the scholarship is disbursed as planned. If the June evaluation is positive and, if it is possible for the student according to the rules established by the Arbour Foundation to apply for a one-

- year renewal of the scholarship, then the student may submit his/her application (Note: a positive evaluation does not grant automatic renewal; the regular selection criteria will also be applied by the Arbour selection committee).
- Should the evaluation be negative, the Arbour Foundation reserves the right to cancel the second instalment (February) and may not allow a student to submit a renewal application. In the event the payment of the second part of the scholarship is cancelled, the student and his or her home university will be notified as soon as possible. It should be noted that the Arbour Foundation makes no judgment on the improvement of the scholar's level of French and relies exclusively on the recommendation of the Fondation pour la langue française.

PLEASE NOTE: If the student decides to take a French course at his or her home university (or any other university in Quebec), he or she will not be required to take the French training provided by the *Fondation pour la langue française*. Their second installment will therefore be conditional on taking the French course and submitting the transcript to the Arbour Foundation upon receipt of his grade for the course.



PRIVACY AGREEMENT CONSENT FORM ARBOUR SCHOLARSHIPS

PREAMBLE

The Arbour Foundation ("the Foundation") awards Arbour scholarships ("scholarships") to MBA, MSc and PhD students in engineering, computer science and business administration at the following Quebec universities: Bishop's University, Concordia University, École de technologie supérieure, HEC Montréal, Institut national de recherche scientifique, McGill University, Polytechnique Montréal, Université de Montréal, Université de Sherbrooke, Université du Québec à Montréal and Université Laval. In accordance with a partnership agreement with these universities, they administer the scholarship competition and submit the best candidates selected by a peer review committee to the Foundation. The personal information of these candidates is therefore transmitted to the Foundation, which complies with all applicable laws regarding the use and retention of personal information.

CONSENT

Your personal information is collected for the processing and evaluation of scholarship applications, interviews, selection of scholars, and administration of their files, as well as the administration and the payment of the scholarships. The selection process requires that your information be disclosed to members of the Arbour Selection Committee and to any other person who may require it for audit, evaluation, selection, administrative or mentoring purposes.

In addition, your personal information may be used in the future to contact you to follow up on your scholarship application or to solicit your support for the Foundation's planned or other giving program. Your name, field of study and/or research topic may also appear in our annual report or any other communication related to the announcement of the scholarship competition results in which you are participating.

Your personal information will also be used to compile statistical data. The Foundation will securely retain the personal information of candidates selected by the universities and whose files they have received. The Foundation shall not to share or sell this information for any other purpose.

No other use or disclosure of your personal information will be made by the Foundation, unless required or permitted by law or authorized by you. The personal information collected as part of this application is limited to that which is necessary for the purposes of evaluating your application and for the purposes indicated in this document.

You may consult your personal information in your file by contacting the Foundation's administration.

You may withdraw your consent at any time. If this withdrawal takes effect during your period of eligibility for the scholarship, your eligibility and our ability to administer payments may be reduced or terminated (i.e., you may not be awarded the award or its payment may be cancelled after you have withdrawn your consent).

By signing and attaching this consent form to your application, you agree to the collection, use, disclosure and retention of your personal information for the abovementioned purposes.
